**Re: 3 year LLB Course and 5 year BBA LLB (Hons) Course 2014-15-
Extension of existing fee structure- Orders Issued**

ORDER

The Fee Regulatory committee has fixed the fees structure for LLB & BBA LLB(Hons) Courses of BHAVAN'S N A PALKHIVALA Academy , basing on the minutes dated 05.09.2013 and communicated it through Letter No: FRC 222/2013/LLB dated 10.09.2013 to the college.

In the above minutes, an inspection of the BHAVAN'S Law College was envisaged. The Committee of experts has been constituted by the Government in G.O (Rt) No. 2092/2014/H.Edn dated 30.08.2014.

As per the email dated 01.09.2014 the BHAVAN'S Law College has requested for the fee fixation for the academic year 2014-15 or to extend the existing fee structure.

In continuation of the letter dated 10.09.2013, the Government has issued the order dated 30.08.2014, constituting the committee with a team of experts to inspect BHAVAN'S N A PALKHIVALA Law college to finalize the tuition fees per semester / annum for BBA LLB (Hons) 5 year Course. The report of the committee is not yet received. Hence the final fees structure for the said 5 year Course could not be decided.

The Fee Regulatory Committee, therefore, decided to extend the existing fee structure for the academic year 2014-15 also.

Similarly, for the 3 year LLB Course, the existing fee structure per semester is also extended to the academic year 2014-15

This fee fixation order for the academic year 2014-15 shall remain in force until modified by the FRC.

G.O (Ms) No. 647/13/H.Edn dated 22.10.2013, granting exemption to certain categories of students, be complied with.

The prospectus for the academic year 2014-15 is not seen submitted by your college. You are, therefore, directed to submit the same immediately so that the admission process could be supervised and regulated by ASC/FRC.

BHAVAN'S N A PALKHIVALA Law college shall continue to collect the fees as per the existing fee structure.
