(Hons) degree programme with two sections of 60 students in each section in Bhavan's N.A.Palkhivala Academy for Advanced Legal Studies and Research (Unaided), Vazhayur, Malappuram (Dt.) for the academic year 2017-18 on conditional basis for obtaining approval from the Bar Council of India-Sanctioned- Orders Issued.

ORDER

Provisional Affiliation was granted for starting Bhavan's N.A.Palkhivala Academy for Advanced Legal Studies and Research (Unaided), Vazhayur, Malappuram (Dt.) with 3 Year L.L.B programme with an intake of 100 students and 5 Year B.B.A. L.L.B. (Hons) programme with an intake of 60 students each for two batches during the academic year 2012-13, vide U.O. read 1st. As per the U.O. read 2nd and 3rd, sanction was accorded for 3 Year L.L.B. and 5 Year B.B.A. L.L.B. programmes with two sections of 60 students in each section in each course for the academic year 2012-13. As per U.O. read 4th, 3 Year L.L.B. programme was disaffiliated from the academic year 2015 -16 onwards.

2. Continuation of Provisional Affiliation was granted to the 5 Year B.B.A. L.L.B. (Hons.) degree programme with two sections of 60 students in each section the college for the academic year 2016-17 as per the U.O read as 5th above on the condition that the college shall produce the approval from the Bar Council of India, and subect to the report of the commission appointed to inspect the locality of the college. As per letter cited 6th extension of approval was granted by the Bar Council of India for the academic year 2016-17 for 5 Year B.B.A. L.L.B. (Hons.) programme.

3. As per the U.O. cited 7th the DLIC Malappuram was instructed to inspect the Bhavan's N.A. Palkhivala Academy for Advanced Legal Studies and Research campus at Vazhayur and submit a report about the progress of the construction of the permanent building there. The DLIC is yet to submit its report to the University.

4.The Principal, Bhavan's N.A. Palkhivala Academy for Advanced Legal Studies and Research, Vazhayur, vide letters read as 8th has requested for the Continuation of Provisional Affiliation to the BBA LLB degree programmes. The institution has remitted ₹95,000/- vide challan no.171006498 dated 13.01.2017, towards Administration and Affiliation fee for the academic year 2017-18, including L.L.M. programme.

5. Considering the above, the Vice Chancellor has accorded sanction, vide the paper read as 9th above, to grant Continuation of Provisional Affiliation to the 5 Year B.B.A. L.L.B.(Hons) degree programme with two sections of 60 students for the academic year 2017-18 also, conditionally, subject to (1) The report to be received from the DLIC, Malappuram and (2) the approval obtained from the Bar Council of India. The affiliation granted by the University for the academic year 2016-17 and 2017-18 will be made absolute only on the basis of the recommendations of the

DLIC Malappuram and the approval from the Bar Council of India.

6. The continuation of provisional affiliation granted shall be subject to the condition that the management should abide by the provisions of the Act, Statutes and Regulations of the University with regard to admission of students, collection of fee etc.

7. Sanction is, therefore, accorded for the Continuation of Provisional Affiliation to the following degree programme in Bhavan's N.A Palkhivala Academy for Advanced Legal Studies and Research (Unaided), Vazhayur, Malappuram (Dist.) for the academic year 2017-18 on conditional basis that the college shall produce the approval from the Bar Council of India and subject to the report of the DLIC, Malappuram about the progress of the construction of the permanent building at Vazhayur.

8. Selection and admission shall be made only on the basis of the Rules and Regulations of the University/Government and on the basis of the directions issued by the University/ Government from time to time, failing which the affiliation granted will automatically be cancelled.

9. In the light of the direction of the Supreme Court of India in WP(c)656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including the withdrawal of affiliation of the college will be initiated.

10. The Conditional Affiliation granted is only for the academic year 2017-18 and subject to the approval from the Bar Council of India and the report of the DLIC about the progress of the construction of the permanent building at Vazhayur. The College has to apply for the continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University, along with a copy of the letter of extension of approval from the Bar Council of India.

11. As per the U.O.No. 5869/2015/Admn. dated 09.06.2015, the conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

12. Admission to the next academic year shall be made only after obtaining prior permission from the University.


